Don Lindow and Bill Gough from Azimuth Capital Management went through their handout on the portfolio summary which was divided into five sections. The first section had graphs on the changes in Gross Domestic Product over time, the second compared returns from the 2, 5 and 10 year Treasury notes. The other charts compared growth in Price to Earnings ratio since 1997 and Equities of the S & P 500 index. The second section showed the GP Shores allocations both overall and the equity allocations. The third sections provided a detailed summary of the system portfolio from April 1, 2010 to August 31, 2016 as well as the detailed returns. The fourth section provided the purchase and sale transactions in the various accounts. They also handed out material obtained from the Commonfund and Cornerstone funds. It was suggested that as staff gets the material from those two outside investments that the material be sent to the board members. The Board discussed with Don and Bill the issue associated with the buyback of stock and on the international level the countries that have negative interest rates. They also mentioned that our portfolio has one bond maturing in October and several next year. Bill mentioned participating in the Ford demo of their autonomous vehicles and that the system purchased Delphi Auto and Snap On Tools.

Staff mentioned that Pension Board members were invited to listen to a presentation by MERS staff to the Finance Committee scheduled for Tuesday, October,11 at 10:30am in the Council Room.
